



Holiday Lights Tour & Contest Guidelines & Agreement for Homeowners

1. Participation is open to all residents within the Westchester and Playa del Rey area.
2. An application to the Westchester Mental Health Guild (“Guild”) with your donation of a minimum of \$25 must have been submitted:
 - a. by regular mail to the Guild, 7891 La Tijera Blvd, Westchester, CA 90045, with your check payable to Westchester Mental Health Guild, or
 - b. by email to info@westchestermhg.org, with your donation by Zelle, or on our website www.westchestermhg.org by PayPal or a credit card, or. Please make sure to make a notation on your payment indication Holiday Lights Tour & Contest Application. or
 - c. by giving it to a Guild representative.
3. **In order to be included in the contest, participants must return a signed copy of this agreement to the Guild, in care of Nancy Edwards, at 7891 La Tijera Boulevard, Westchester, CA 90045, or by email to info@westchestermhg.org, or give it to a Guild representative no later than December 1, 2022.**
4. The contest is for exterior decorations only, including decorations in windows that are visible from the exterior.
5. Displays must include lights so that the display is visible after dark.
6. **Participants should ensure that all lights, animations, and decorations are in place and activated from 5:00p.m. – 9:00p.m.**
7. A list of addresses (without family names) and a ballot will be available for a donation of \$10 through Eventbrite. Participants are encouraged to promote the fundraiser contest with their friends and family and ask them to vote.
8. **Voting for the contest will take place from December 10 – December 20, 2022. However, opportunities for viewing the holiday decorations will continue to December 26, 2022.**
9. The Guild will supply your home with a yard sign. We will also provide a solar spotlight for it and tour-goers driving by can identify your home as part of the Tour. **Following the conclusion of the contest Guild Member/Volunteer will come by to retrieve the yard sign and the solar spotlight.**
10. Participants agree to have one or more photographs of the exterior of their decorated residence as well as their address posted on the ballot to be made available to registered voters.
11. Participants hereby give the Guild all rights to such photos and agree there is no compensation of any kind for any use of such photographs.
12. Photographs of winning homes will be posted on the Guild website, on social media, and in the *HomeTown News* and other print media, with the names and addresses of the winners. Participants agree there will be no compensation of any kind for said posting or publication.
13. Homeowners participating in the contest will receive a complimentary tour ticket, with a listing of the other homes in the contest, so they can vote.
14. **Winning homes will be announced on Tuesday, December 21, 2022, and notified by telephone. Winners agree to post a Guild sign in their yard announcing their winning status.**
